

Trip Waiver

Any Simmons student and their guest participating in any Simmons sponsored events taking place off campus must complete and agree to the following information listed in this form.

Waiver/Responsibility

I understand that there are inherent risks involved with traveling which are beyond the control of Simmons College. During my participation in this Trip, I hereby grant Simmons College and its employees and deans full authority to take whatever actions they may consider to be warranted under the circumstances regarding the protection of my health and safety.

I hereby agree to comply with all rules and instructions regarding student behavior which are promulgated by Simmons. I understand that while on the Trip I shall be subject to the laws of that city/country. I understand that I shall be viewed as a representative of Simmons College, and I agree to represent myself in a fashion that will represent Simmons College in a positive manner. I agree to abide by the Code of Conduct for off-campus trips. (need to refer to location of Code of Conduct)

When participating in group activities, I agree to accept the will of the majority whenever a matter of choice is presented to the group. I understand and agree that I shall listen to the directions of the Trip supervisor(s), who may be a peer of mine, to minimize risk to myself and others.

In consideration for being permitted to participate in the Trip, I agree to assume all such risks and dangers, and to release and forever discharge Simmons College, its Trustees, officers, employees, and deans from any and all loss and liability in connection with any personal injury, accident, damage, claims, costs, expenses or other loss caused, suffered or incurred by or to me arising out of or in any way associated directly or indirectly with my participation in the Trip.

I understand and agree that my conduct may lead to my immediate dismissal from the Trip. If my participation in the Trip is so terminated, I agree to accept the decision of termination, and to return to Boston immediately thereafter, at my own expense. I further agree that, if I am terminated from the Trip, Simmons College shall have no obligation to refund to me any portion of the fees or other monies I paid to participate in the Trip.

I understand and agree that all deposits and payments for or in connection with the Trip are non-refundable.

I understand that in the event I develop legal problems with any city/state/national/international government, I shall be required to attend to the matter personally, and with my own personal funds.

I agree to exonerate, indemnify, and hold Simmons College, its administrators, deans, Trustees, officers, employees, and agents harmless from and against any and all obligations, liabilities, actions for which I may become liable while participating in the Trip.

I understand that Simmons College cannot be held responsible for any injuries, loss or damage to me or to my property; including if I choose my own transportation and/or lodging for this trip. In consideration for being permitted to attend this Trip, I agree to assume all such risks and dangers, and to release and forever discharge Simmons College, its Trustees, officers, employees, and deans from any and all loss and liability in connection with any personal injury, accident, damage, claims, costs, expenses or other loss caused, suffered or incurred by or to me arising out of or in any way associated directly or indirectly with my participation in the Trip.

Code of conduct

Each person attending an off campus trip sponsored by Simmons College is expected to abide by the Simmons College Code of Conduct for the trip. This document outlines what is expected of each traveler attending an off campus trip (herein after referred to as the "Trip"). Beyond respectful, courteous, mature, and ethical behavior, Simmons College also insists upon the observance of the highest moral standards by Trip attendees. Each Trip attendee must agree to the following Code of Conduct with regards to the Trip they are attending:

Exhibit respectful and courteous behavior at all times toward Trip leaders and others (staff from other institutions, bus drivers, hotel or program staff, other students, etc).

Understand that any behavior that compromises the good name of Simmons College is unacceptable and may result in dismissal from the Trip, including transportation, which will require the student and guest (if applicable) to secure individual travel back to Boston.

Prompt attendance in designated locations at designated times in line with the schedule provided by the Trip leader. Failure to comply may result in being left behind and being responsible for securing his/her own transportation to the intended destination.

Incendiary materials, knives, and weapons are strictly prohibited.

The use, possession, distribution, or sale of illegal drugs or controlled substances (including alcohol, even if of age) and paraphernalia oriented to it is strictly prohibited.

Trip attendees are expected to uphold the Code of Conduct and represent Simmons College at all events and during all traveling. Additionally, trip attendees are expected at all times to show respect and consideration for the personal and property rights of others and cooperate with the directives of the designated Simmons College Trip Leaders. Failure to fall this Code of Conduct may result in disciplinary action.
